

# **ALFAPLAST SUPER 100**

# Multi purpose high range water reducing admixture based on PCE Technology

#### **DESCRIPTION**

ALFAPLAST SUPER 100 is differentiated from conventional superplasticisers in that it is based on a unique carboxylic ether polymer with long lateral chains. This greatly improves cement dispersion. At the start of the mixing process an electrostatic dispersion occurs but the presence of the lateral chains, linked to the polymer backbone, generate a steric hindrance which stabilizes the cement particle's capacity to separate and disperse. This mechanism considerably reduces the water demand in flowable concrete.

ALFAPLAST SUPER 100 combines the properties of water reduction and workability retention. It allows the production of high performance concrete and / or concrete with high workability.

### STORAGE / SHELF LIFE

This Product must be stored where temperatures do not drop below +5°C, If product has frozen, thaw at +5°C or above and completely reconstitute using mild mechanical agitation. Do not use pressurized air for agitation. Store under cover, out of direct sunlight and protect from extremes of temperature.

Shelf life is 12 months when stored as above.
